

Monthly Summary Report of October, 2023

I Financial Position of States

The month of October, 2023 saw a downward trend in the States' monthly fiscal assets as compared to September, 2023. The daily fiscal assets of the States at the end of the month of September, 2023 were Rs. 2,09,799.60 crore, whereas at the end of the month of October, 2023 the daily fiscal assets of the States were Rs. 2,07,806.44 crore.

During the month of October, 2023, a total of Rs. 2,729.22 crore was released as Additional Central Assistance (ACA) for Externally Aided Projects (EAPs) to States as per the details given in the Table below:

Consent for Open Market Borrowing (OMB) and Negotiated Loans (NL) allowed to the States:

During the month of October, 2023; Government of India (GoI) consent under Article 293(3) of the Constitution of India for raising Open Market Borrowing (OMB) for an amount of Rs. 17,119.00 crore was issued to States. Similarly, consent under Article 293(3) of the Constitution of India for availing Negotiated Loans (NL) of Rs. 940.11 crore from Central Financial Institutions (CFIs) was also issued to States.

During the month of October, 2023, as per the recommendations of the 15th Finance Commission, a total of Rs. 7,339.56 crore was released to the States as per the details given in the following Table:-

In addition, a sum of Rs. 72,961.21 crore was released by Department of Economic Affairs as share of Central Taxes and Duties to the States during the month of October, 2023.

Scheme for Special Assistance to States for Capital Investment:

During the month of October, 2023, Capital Expenditure amounting to Rs. 200.88 crore was approved under Part-I (Untied) of the Scheme to the State of Jharkhand and an amount of Rs. 3,885.79 crore was released to the eligible States under the Scheme for Special Assistance to States for Capital Investment 2023-24.

Also, an amount of Rs. 618.26 crore was approved for the States of Goa, Maharashtra, Odisha and Uttarakhand and an amount of Rs. 309.13 crore was released to the States under Part-VI (Construction of Unity Malls) of the Scheme for 2023-24.

Further, an amount of Rs. 1,516.40 crore was approved for the States of Assam and Uttar Pradesh and an amount of Rs. 758.20 crore was released to the States under Part-VII (Children and Adolescent's Libraries and Digital Infrastructure) of the Scheme 2023-24.

In all, Capital Expenditure amounting to Rs. 96,206.27 crore has been approved and an amount of Rs. 58,494.19 crore has been released to the eligible States under the Scheme for Special Assistance to States for Capital Investment for 2023-24 till October, 2023.
